

Well, it's an incredibly scientific process that has been refined for years and years, and I guarantee does not involve any adult beverages.

Cheverly Day is Right Around the Corner: Folks, Cheverly Day is coming soon. The Cheverly Day Committee has decided that Cheverly Day needed to have a fixed date every year so that people can plan around it. So it is now been decreed that for now, and forever more into the future, Cheverly Day will be held on the third Sat of May (unless of course we change it).

I hope everyone will put this date on their calendar, because we are looking to have the best Cheverly Day ever. We've ordered up the weather from last year, and we'll return the Mini Golf Course, the Ping Pong Ball Flume, Corn Hole, Dunk Tank and all the other great events from last year.

Remember the New Recycling Policy: Please remember that we are no longer allowed to place any type of thin plastic item (trash bags, sandwich bags, thin plastic film, etc) in our recycling.

The county facility simply can not recycle these items, and worse yet it clogs their machines causing lots of wasted time by the workers.

Furthermore, Public Works will not pick up any recycling that is placed in a clear or opaque plastic bag. However, you can place your recycling in any other trash can or box. Many residents simply use a normal trash can (no more than 35 gallons) or place their recycling in a box that they were also recycling.

Getting to Zero Waste: I have been very surprised at how much my regular trash has increased by placing the plastic bags in our regular trash versus the recycling stream. It seems like plastic bags multiply. We get them in the store, they cover the newspapers, and they are used as wrapping for most food items. While the trash from plastic bags is not very heavy, it has increased the volume.

Many folks have asked if we can do a special collection specifically for plastic bags. Unfortunately, the town has no place to bring the bags once they have been collected, so we really can't do this. It is possible for residents to bring the plastic bags back to most grocery stores and we ask you to do this if you can.

However, one step we can all take is to bring reusable bags to the grocery store in order to stop the use of plastic bags. I know this is an inconvenience, and I for one frequently forget the bags and leave them in my car. However, if we all started to use reusable bags, we could really make a dent in the number of plastic bags that end up in the landfill.

New Recycling Bins: “Wonder of wonders, miracles of miracles”. (Can you tell that Peg and I just saw Fiddler on the Roof?)

In an effort to help residents better manage their increased recycling loads the council voted to approve a pilot purchase of 330 new 35 Gallon Recycling Bins. These bins are blue, have wheels and a lid. They are easy to get to the curb, and the lid prevents paper from blowing around the neighborhood. These bins retail for approximately \$70, however Public Works is selling them to residents for only \$20. If you call Public Works at (301) 773-2666, and arrange to pay the \$20, Public Works will drop a bin at your home. Currently we are limiting each resident to a single bin, but if demand continues we will make second a purchase. So far we have sold approximately 190 of the 330 bins.

Of course, you don't need to use these new bins. If you are comfortable with the old bins, or are using other receptacles please feel free to continue to do so.

Speaking of Recycling, What About Appliances: Some residents have asked, why isn't my old appliance recyclable or at least eligible for Electronic Recycling. Well it turns out that appliances require special handling by town staff. So if you are disposing of a washer, dryer, stove, refrigerator, air conditioner, water heater or microwave (of any size) please contact Public Works at (301) 773-2666 to make arrangements to have the appliance removed. Public Works charges \$20 for the special processing associated with these pickups. If you simply leave it at the curb, Public Works will pick it up, but you will receive a bill for \$20 and a fine for \$25.

It is always best to have these appliances removed by the company that is delivering the new appliance to your home. Generally, they will not charge you a fee.

Cheverly Opposes Rail Yard at Landover Metro:

Remember last month when we discussed the potential for WMATA to place a rail yard at the Landover Metro Station? Well it turns out WMATA is considering placing two rail yards in the same area. Honest! After we began conversations with WMATA about the first rail yard, they mentioned that a second rail yard was potentially being placed further down Pennsy Drive.

A small group (Green Infrastructure, Planning Board, Vice Mayor Eldridge and I) met with WMATA representatives to discuss this topic. While we were not supportive of their plans we did ask them to investigate other options that would spare the Metro Station from any intensive industrial use such as a rail yard. The options discussed were: 1) Place the second yard elsewhere on the metro system and place the rail yard planned for the Metro Station at the secondary site. 2) Combine the two sites and purchase more property at the secondary site and place both rail yards at the second site, sparing the Landover Metro Station, 3) If a rail yard had to be located at the Landover Metro Station, then please mitigate the impact by placing a cover over the site.

We are planning a larger meeting with WMATA during the week of February 9th and will invite residents to this meeting. We hope to have a large turnout at this meeting in an effort to be persuasive.

Did You Receive Your New Tax Assessment? Please pay attention to this document that you should have received just before the January 1st. Every three years the County uses a formula, based on recent sales data, the size and type of home, and any new permitted construction to determine the value of your home. Your assessment is extremely important because it determines how much in property taxes you will pay. The formula to determine your taxes is very straightforward (tax rate * (assessment / 100)). So the amount of your assessment is a significant driver of your total tax bill.

Quick Notes:

- If you own the home you are living in, and you have claimed the Homestead Exemption your assessment can only increase 10% per year until the new assessment value is reached.

- If you do not live in the home your assessment will increase 33% per year until the new assessment value is reached.

- If you plan to contest your assessment, use current sales data and compare your assessments to other comparable homes. All of this data is public and can be found at the state website: <http://sdat.resiusa.org/RealProperty/Pages/default.aspx>

How do Increased Assessments affect the Town? When the council considers how to develop the next three year budget plan, understanding how the assessable tax base will grow is a critical factor. In the last budget cycle, the assessable tax base shrank 21% and had zero growth over three years. This required us to raise the tax rate simply to keep the Town Revenue flat.

We have yet to receive the updated assessable tax base from the county, and may not get this number until late February. Until the Council gets the assessable tax base number it is difficult to develop a clear three year plan.

However, it is clear that there will be growth in the base. Once we understand how much the assessable base is going to grow, we can better plan how the impact on our Tax Rate, which is currently .58 per \$100 of assessed value.

Property Taxes are Cheverly's Major Revenue Source: In past years, I have provided detailed breakdowns on each Revenue and Expenditure category in the budget. If you check the 2013 February, March and April Newsletters (can be found on the Town Website) you will find a lot of detail. Given the Budget has remained flat, not much has changed since then.

One point of emphasis is: Property Taxes still remain Cheverly's major source of revenue, especially given cutbacks in other state programs. Property Tax Revenue is approximately 58% of the Town's total revenue stream.

Town Staff has done an excellent job of continuing to provide outstanding services to Cheverly residents, even though property tax revenue and total revenue has actually slightly decreased since FY12, and has grown by only 9% since FY10.

New Street Light for the BW Parkway Bus Stop: By the time you read this the Town Council will have considered whether to spend \$1,100 to replace the Street Light next to the Bus Stop on the entrance to the BW Parkway. This has been a three year journey of frustration, Apparently there are no records as to who built or owns this Street Light that is always out. The property is owned by the National Park Service, the Bus Stop is owned by WMATA and of course the County has some involvement. However, none of these entities will claim the light, and Pepco has stated that the light was not implemented by them because it is not there technology.

Two years ago, after much haranguing we did manage to get Pepco to fix the light, but they insisted they would never fix it again unless the technology changed. When the other parties were asked to pay for the technology transfer, there was the deafening sound of crickets.

Based on the safety of the Bus Riders and of the drivers who come down the ramp, we have placed this purchase on the January 29th work session agenda. Hopefully the expenditure will pass, and the light will be fixed forever into the future.

Helicopters; *Hey Mike, don't you live near the hospital? Hey Mike, do you hear the helicopters? Hey Mike, why the heck do they fly over the town at such low altitudes?*

Yes, Yes, and I don't really understand. First the good news, the helicopter problem is so much better than it was five years ago. The number of flights in and out of the hospital is dramatically reduced and the policy of keeping the propellers running while on the roof has been changed. These are good things.

Unfortunately, it appears that the helicopter pilots are increasing flying over town and at ever lower altitudes. The Council has heard this complaint loud and clear and has addressed this with the hospital. Unfortunately, there are many different organizations that fly to the hospital and the hospital itself has little control over the organizations.

Therefore, the Town will be contacting each organization and emphasizing the Good Neighbor Policy regarding flights over the community. Of course there will always be some flights over the town based on urgency and wind patterns. However, we are working to get them reduced.

Looking for a Good Meal? While its great that we have a new Ledo's and a refurbished Landover Restaurant, there are still many good opportunities to eat at our local non-profits.

February will bring us a Sweetheart Charity Ball on February 6th (Great Dancing), Pancake Dinner on February 18th (Great Pancakes) and a Spaghetti Dinner (Great Spaghetti) on February 22nd.

WINTER WEATHER REMINDERS

TOWN CODE - Sec. 27-10—Parking

A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more. The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.

PARKING RESTRICTIONS: During a snow emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts,
- On the even-numbered side of all streets,
- **(exception)** On the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Bellevue Avenue.

NOTE: The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.

PRIORITIES: The snow removal operations work under the following priorities: 1.) Cheverly Avenue 2.) principal connecting streets: Forest Road, Crest Avenue, Valleyway, Greenleaf Road, 62nd Avenue, State Street, Schuster Drive; 3.) all other streets.

TOWN CODE Sec. 18-4.1—SIDEWALKS

Whenever snow accumulates to a depth of one inch or more, it is the duty of each occupant to clear the snow from the sidewalk adjacent to that property, within 12 hours after the snow ceases, (unless at night, in which case it shall be removed within 12 hours after sunrise). Snow and ice removed from sidewalks shall NOT be deposited on streets or other sidewalks.

When ice forms on sidewalks, occupant shall place sand, ashes or other such material on sidewalks within 6 hours, (unless at night, in which case it can be spread by noon of the next day). Icy spots on public property can be reported to Public Works at **301-773-2666**.

The meeting will be held in the Cheverly Station Apartment Leasing Office located at 6501 Landover Road. We will be talking about general crime in 2014 as well as specific issues central to the apartments area. Everyone is entitled and encouraged to attend this meeting.

JUST WANTED TO REMIND ALL CHEVERLY RESIDENTS:

301-789-5090

A cell telephone with the above number is maintained by patrol officers working the streets of Cheverly daily, from 5:00 PM until 5:00 AM (outside of our normal office business hours). In a manner similar to the Cheverly Watch Radio Program, this cell telephone can be contacted for the following reasons:

1. To report a crime in progress;
2. To report a suspicious person, vehicle, or circumstance;
3. To report an emergency situation (traffic accident, tree or wire down, fire, etc.);
4. To report a solicitor;
5. To obtain a vehicle impound release when the office is closed; or,
5. To provide a tip about a previous crime, a wanted person, or criminal activity (rewards are available).

This telephone shall not be called for the following:

1. To report a routine call for service or a call requiring a report only;
2. To seek information about an outstanding case or obtain a copy of a report;
3. To seek legal advice or general assistance.

Note: The non-emergency telephone number for routine calls for service is 301-352-1200 and the number for the Department’s daytime hours is 301-341-1055.

Special Note: This is a trial only to see how effective this new program can be. Remember, just like Cheverly Watch, officers will not answer the telephone when they are on a call or are processing a prisoner. In addition, and there may be certain gaps in service where officers may not be available. In those circumstances, you are urged to call 911 for emergencies or 301-352-1200 for non-emergencies

GENTLE REMINDER ABOUT WINTER SNOW

REMOVAL: If you are a resident of Cheverly, please be reminded that snow lying on sidewalks in front of their residents or rental properties must be cleaned off by the owner/occupant within 12 hours after the snow has ceased to fall, or if falling at night, within 12 hours after sunrise the next day. Snow cannot be deposited on public streets or sidewalks. In addition, owners/occupants are also required to apply the appropriate material (i.e., sand or similar compound) to ice covered sidewalks within 6 hours of when such ice has formed.

Failure to adhere to such requirements will result in the issuance of a municipal infraction with a fine of \$50 for the first violation and a \$100 fine for each repeated offense. Every day that a violation continues shall be deemed a separate offense. For more information, see Town Code Section 18-4.1.

LEAF COLLECTION PROCEDURES

Vacuumping Leaves: Every street in Cheverly is scheduled for at least 2 vacuumping sweeps.

Rake leaves **between** the curb and sidewalk - not on the street or sidewalk.

- Keep leaves free of twigs, branches, metal, concrete and other debris that can jam or damage the equipment.
- Please do not park cars on the street on the assigned collection day
- Be considerate of your neighbors. Only rake to curb when your pick up day is imminent. Raking too early, allows the leaves to blow into your neighbors yard.

Bag Leaves: Yard waste is collected on **MONDAYS**

Put bags at the curb on Sunday evening. Use **Paper Bags** or trash cans only. Yard waste includes leaves, grass, brush, twigs, etc. Do not put any dirt, rocks, or other trash/debris in these bags. If you have any questions, please call Public Works at 301-773-2666.

**SOLID ANIMAL WASTE
 ORDINANCE**

Sec. 4-10 (a) It shall be unlawful for a person controlling an animal, except a seeing eye dog, to allow or permit solid waste of such animal to remain on the property of any other person without the consent of the owner or occupant thereof; or on such public properties as are prohibited by order of the Mayor and Council of the Town of Cheverly. Prohibited areas are sidewalks, Gast Park, American Legion Park, Boyd Park, & play areas of all other parks.



SAFETY REMINDER:

We ask residents to remember that your neighbors who walk to Metro, or children walking to school, and the hard working Mail Carriers are exposed to dangerous conditions when sidewalks are not cleared in a timely manner. Failure to comply with Town Code could result in fines.


This article is the product of receiving several calls from residents troubled by the recent County, recycling, center changes to the collection of materials. It must be understood that Cheverly does not have its own recycling center; we take our recyclables to the County's recycling center in Capitol Heights. Therefore, we must obey their rules; even if we do not agree with them.

Some residents returned recycling bins back to public works and left them in the front of the building and others called saying they intended to throw everything in the trash. Well your frustration is understood but recycling is needed and recycling is "mandatory" within the corporate limits of Town of Cheverly. (Town Code Chapter -10 Sec. 6, 7.)

The Town's ordinance requires that every household in Town take the necessary steps to recycle. But, when disposal and bury at the landfill is examined next to recycling - it is clear that for Cheverly - recycling is the clear winner without even valuing the environmental benefits.

Why not recycle? Is it not a sound financial decision? Does the earth have unlimited raw materials? Shouldn't we just bury it all? What about landfill space? It is a pain to recycle?

Recycling does the earth and the environment good. It does not cost The Town a penny. The earth does not have unlimited supplies of raw materials and recycling is a way of saving those materials. Very few places want to have a landfill in their area; few individuals want to live near one, and those places that do have landfills want to close them. Burying trash is becoming quite expensive as space becomes scarce. If we think that it is a pain to recycle consider not having the material because it was all used up.



The responsible thing to do is to recycle everything that stops the depletion of the earth, can replenish its nutrients, has a market value and curbs the use of raw materials around the world. But in order to recycle more of these materials there must be a sound method of collection, of processing the material and a market. Just because it is recyclable, does not mean that the Town has the means of collecting it, that there is an accessible processing plant and/or a market for the collected and processed product.

The Town regulation about recycling is clear and now with the new recycling containers, recycling ought to increase.

During the next few weeks, at random, in accordance with the town's ordinance the public works crews will be inspecting refuse containers for recyclables. Those consistently found with recyclables inside will be recorded and a letter sent requesting compliance. (Town Code Chapter 10 – (d) (1) ((2) (a) (b) (c))

Hopefully each one finds recycling valuable and a privilege.

Great Backyard Bird Count and Nature Hikes in Cheverly February 14th and 15th

The PG/AA Chapter of the Maryland Native Plant Society and the Cheverly Green Infrastructure Science Advisory Committee are co-sponsoring nature hikes, coupled with the Great Backyard Bird Count of local birds, under the auspices of the Audubon Society and Cornell Lab of Ornithology on four days (Friday through Monday) from February 13th to the 16th, 2015. Two public hikes are planned for Saturday and Sunday, February 14th and 15th at the Woodworth and Nature Parks respectively. Both hikes will be guided by experienced bird watchers. We will also be identifying trees and whatever native plants we come across. This is a great chance to get out, learn about birds and enjoy what nature has to offer this time of the year.

General Directions: Approach Cheverly from either south or north on B-W Parkway; take the exit for Cheverly onto Rte. 202 (Landover Rd), head east a few hundred feet and turn right onto Cheverly Ave heading south. Continue for six blocks to Forest Rd, after a small park on your left; from there follow specific directions for each hike below. Woodworth Park, 6401 Forest Rd, Cheverly, MD. For Saturday hike at Woodworth Park turn left on Forest Rd. Follow it for about 4 blocks; on your right you will see the Town Hall at the end of a long entrance drive (opposite 64th Ave) Free parking is available on left side of Town Hall.

Cheverly Nature Park, after 3398 Tremont Ave., Cheverly, MD. [Address is for orientation only; owners are not associated with the hike]. For the Sunday hike turn right on Forest Rd and continue three blocks until the road splits; stay to the right and continue straight ahead for two more blocks passing Crest and then turn right on Tremont Ave; go to its end and park on street.

You will need a pair of binoculars; bird or plant guides are optional, but be sure to dress appropriately for the weather. Note: Fairly easy walking on good trails, but there are some slopes to climb. May be cancelled for heavy rain, wind, or other inclement weather. Call 301-341-1261, if in doubt.

If you can't make it to either of the public outings, you can simply observe and count birds around your home or neighborhood during any of the four days of the count and still make a contribution to science. 


