Detailed Site Plan for The Ridges at Landover Metro Approved:

The Ridges at Landover Metro is a development of 165 town homes and 193 condominiums planned for the vacant lot on Landover Road (Route 202) between Pennsy Drive and 75th Avenue. This 23 acre lot has been vacant since approximately 2005 when the previous apartments were removed.

Over the years the Town Council and Planning Board have attempted to influence the development to be more Transit Oriented (ie: more density with taller buildings, better access to metro and more green space), unfortunately these concepts have not been incorporated by the developer.

On the positive side, we will be seeing new housing options near Cheverly and the Landover Metro that promise to have reasonable access to Metro routes. We hope that this development will be successful and continue to bring attention to our area.

Recycled Asphalt Plant coming near

Cheverly: Many Cheverly residents are unaware of the significant Industrial uses south of Route 50 and just south of our town boundaries. For years, Cheverly has worked with neighboring community organizations and Progressive Cheverly to improve conditions in the industrial area;

- Opposition to Concrete Plant: (Lost)
- Opposition to Auto Salvage: (Won)
- Influence Industrial Traffic: (ongoing)
- Address Environmental Justice Issues: (on-going)
- Address zoning issues: (on-going)

Recently we learned that a Recycled Asphalt Plant (RAP) is coming to the Industrial Park. This plant is taking the place of a former Asphalt Production Facility. Cheverly will work with neighboring organizations to attempt to prevent it, however, it most likely will be allowed. There are no zoning hearings required as this will be located in a Heavy Industrial Zone (I-2) area. The Recycled Asphalt Plant does require a permit from MDE (Maryland Department of Environment). The Public Hearing for this permit is December 10th at 6:30pm at the Prince George's Ballroom located in nearby Kentland.

Some good news is that our previous litigation has ensured that Air Monitoring will be installed at the Industrial Park near the Concrete Plant. This monitoring will allow us to better understand what issues truly exist near the park.

Speaking of the Concrete Plant: As I mentioned above, the owners of the concrete plant are beginning the process of construction. While I indicated that we “lost” in our opposition to the Concrete Plant, we did manage some significant concessions. First we were able to get the Concrete Plant to implement Air Quality monitoring on site. Second we were able to ensure that the Concrete Plant would be fully enclosed and that the exterior would have a “look” more befitting of an office building. We are working with all parties to get the Air Monitoring capability deployed soon, so that we can create baseline prior to the construction of the Asphalt Plant.

The consultants provided a very professional presentation that encompassed all previous planning efforts for our area as well as outlining opportunities and issues. After the presentation, citizen groups broke into groups of eight to ten to discuss and provide recommendations in three specific topics: Place Making Urban Design and Hospital Site, Environmental Concerns, and Multi-Modal Transportation.

While many of you were unable to attend, there is still ample opportunity to provide feedback.

Park and Planning has a web page dedicated to the Cheverly Sector Plan. http://www.pgplanning.org/Projects/Ongoing_Plans_and_Projects/Community_Plans_and_Studies/GCSP.htm On this site you will find the presentation given by the consultants and a WikiMap where you can interact-ively provide feedback to the consultant team. A second meeting will be held in either Jan or Feb. The Town will provide notice as soon as the meeting dates are set.

I’d also like to mention to everyone who participated in the Envision Cheverly Process that your input has already been given as the document was one of the primary inputs to the process.

Pepco Tree Trimming: Pepco and the Town Council finally agreed on a plan for Public Property tree trimming. Pepco is now finalizing their plans and we can expect to soon see their trucks in our community. While the Town Council was able to provide input as to tree removals, we unfortunately do not have the same level of input into exactly how trees are trimmed.

Pepco tree trimming is done to standards adopted by the State Legislature regarding how close to wires branches can be, factoring in a four year growth period. The “how” branches are trimmed is done to standards agreed to with the Department of Natural Resources.

I am sure, I will hear from many of you during this process. Feel free to raise your concerns.

Leaf Collection: Look inside the newsletter for the Cheverly Leaf Collection schedule for this Autumn. Public Works does a great job of collecting un-bagged leaves at the curb; however it is important that you bring your leaves to the curb during the proper time for your street.

Many times I get complaints that Public Works has asked residents to bring their leaves back from the curb, because it is not their scheduled time. Public Works does this because the leaves will blow into streets and neighbors yards causing more work for others. So please take advantage of the curb side service, but make sure to bring your leaves to the curb at the right time.

Of course, you can always bag your leaves and take them out for Monday Yard Waste Pick-Up. Please Remember: No Plastic Bags Allowed. Your leaves will not be picked up if they are in plastic bags.

Fall Clean-Up; Bundled in four foot

segments: During the Fall many folks take the opportunity to clean their yards, sticks, branches, and shrubs all come to the curb side. Please remember to cut all awkwardly shaped vegetation into four foot segments and bundle them with twine or rope. While this may seem a tedious task it improves the service of our Public Works Staff and prevents them from many unnecessary cuts and scratches.

NEW SMOKING IN A VEHICLE

PROHIBITION – As of October 1, 2015, the driver or any passenger in a motor vehicle may not smoke any tobacco product in any vehicle occupied by a child less than 8 years of age. This new law carries a \$50 fine for each violation and is not considered a moving violation under Maryland law.

SPECIAL HOME SECURITY SURVEYS – As you may be aware, the Cheverly Police Department regularly conducts free home security surveys for all residents of Cheverly. These surveys generally take about one hour and the cost of suggested security improvements generally ranges below \$200. In addition to regular security checks, we also have surveys tailored toward residents who live alone, who travel frequently, who are elderly, or who have been or are currently in domestic situations where there is a protective order or peace bond. Please call to make an appointment today at 301-341-1055 and you do not have give a reason for the request. If you have any questions or need a consultation, please ask for Chief Robshaw.

Residential ZONE Parking Permits

- You must have Vehicle Registration (registered to Cheverly address) to register your vehicle
- Parking Permits cost \$5 / 1 Guest Parking Permit allowed per residence at no cost.
- \$2 for an additional Guest Parking Permit (*maximum of 2 guest permits per residence*)

If you live in one of the following zones, you will need a parking permit:

Zone 1: State Street, 61st & 62nd Avenues, as well as the 1800 Block of 64th Avenue.

Zone 2: ELIMINATED (6/13/2013)

Zone 3: 22-2400 blocks of Cheverly Avenue

Zone 4: Arbor, Crestlawn, **[22-2300 blks Parkway] (ELIMINATED)**

Zone 5: 2300 block of Belleview

Zone 6: Benton Road; 23-2500 Blocks of Lake

Zone 7: 2400 block of Valley Way

Zone 8: 3300 Belleview; Medical Terrace **[Lockwood Road, 5600blk Jason, 32-3300blk Tremont] (ELIMINATED)**

SR: The odd side of the 2200 Block of Cheverly Avenue

(This permit allows senior citizens 65 years of age or older to park their car in this area in order to utilize Metro)

Residential Parking Permits are displayed on the BACK LEFT bumper area.

If you have a regular zone permit and a SR permit display them next to each other on the back left bumper.

Guest Parking Permits shall be hung on Rear View mirror with information facing outward.

Citations may be issued to any vehicle not in compliance with Town Code 27-5.1: "Residential Zone Parking"

WINTER WEATHER REMINDERS

TOWN CODE - Sec. 27-10—Parking

A snow emergency shall exist whenever snow has accumulated on the streets to a depth of one (1) inch or more. The provisions of this subsection shall be effective without any notification and shall remain in effect until the street is plowed; provided, however, that when snow shall accumulate to a depth of one inch or more after 11:00PM, the provisions of this subsection shall not be effective until 7:00AM the day following and shall remain in effect until the street is plowed.

PARKING RESTRICTIONS: During a snow emergency no person shall park any vehicle as follows:

- On the cul-de-sac portion of any street,
- On any courts,
- On the even-numbered side of all streets,
- **(exception)** On the odd-numbered side of 59th Avenue, and one block of Inwood Street between Cheverly Avenue & Belleview Avenue.

NOTE: The snow emergency parking restrictions do not override existing no-parking zones or apply to streets where enforcement would disallow all parking because of a no-parking zone, or to streets with any barrier or strip dividing lanes of traffic.

PRIORITIES: The snow removal operations work under the following priorities: 1.) Cheverly Avenue 2.) principal connecting streets: Forest Road, Crest Avenue, Valleyway, Greenleaf Road, 62nd Avenue, State Street, Schuster Drive; 3.) all other streets.

TOWN CODE Sec. 18-4.1—SIDEWALKS

Whenever snow accumulates to a depth of one inch or more, it is the duty of each occupant to clear the snow from the sidewalk adjacent to that property, within 12 hours after the snow ceases, (unless at night, in which case it shall be removed within 12 hours after sunrise). Snow and ice removed from sidewalks shall NOT be deposited on streets or other sidewalks.

When ice forms on sidewalks, occupant shall place sand, ashes or other such material on sidewalks within 6 hours, (unless at night, in which case it can be spread by noon of the next day). Icy spots on public property can be reported to Public Works at **301-773-2666**.

The Town's Storm Drains Impacts....

Please read carefully the following statements; the Town's storm drain structures do not carry liquids/fluids/rain water to a water treatment facility. Liquids/fluids/rain water entering the Town's storm drain structures flow into a system of water pipes and creeks which eventually outfalls into the Anacostia river. These liquids/fluids/rain water contributes to the pollution of this waterway and further down the Chesapeake Bay..



Storm drain structures are necessary. These structures are required to manage the potential flooding created by improved, impervious surfaces such as sidewalks, driveways, roads and others. Actually there is nothing inherently wrong with a storm drain system.



However, there is a problem with the storm drain systems. This problem is the result of human activity within the urban and suburban areas where the structures are typically installed. Simple, unknown, often innocent acts of human interaction make the storm drain a contributor to water way pollution and we all need to do something about it.

Let us consider what measures I/we can take to remove pollutants from the storm drain system.

1. Eliminate the use of fertilizers; if you must use them, never apply them prior to a down-pour.
2. Stop using lawn chemicals/pesticides; seek natural alternatives.
3. Remove all animal waste from lawns and remove it from all curbs and sidewalks.
4. Stop throwing cigarette butts out the window.
5. Stop emptying the cars cigarette ashtray container while stopped at a traffic light.
6. Inspect and eliminate vehicle fluid leaks over improved/impervious surfaces.
7. Remove all litter from the curbs especially plastic grocery bags.
8. Stop washing/cleaning paint brushes at an outside faucet that flows to the curb.
9. Stop hosing driveway leaves/debris towards the curbs or into the stormdrain.



The list above is just a starting point for our awareness; you may have others, but the point is simple; let each of us do something for all of us. There are over 20,000 bodies of water in the U.S. that are impaired; let us make sure that Cheverly does not negatively contribute to this number.

LEAF COLLECTION PROCEDURES



Vacuuming Leaves: Every street in Cheverly is scheduled for at least 2 vacuuming sweeps.

Rake leaves **between** the curb and sidewalk - not on the street or sidewalk.

- Keep leaves free of twigs, branches, metal, concrete and other debris that can jam or damage the equipment.
- Please do not park cars on the street on the assigned collection day
- Be considerate of your neighbors. Only rake to curb when your pick up day is imminent. Raking too early, allows the leaves to blow into your neighbors yard.

Bag Leaves: Yard waste is collected on **MONDAYS**. Put bags at the curb on Sunday evening. Use PAPER BAGS or TRASH CANS Only. Yard waste includes leaves, grass, brush, twigs, etc. Do not put any dirt, rocks, or other trash/debris in these bags.


Holiday Gifts for Employees -
